## *Looking Ahead at 2023*

The new year is in full swing and Local 338 is already busy gearing up for what 2023 has in store for our union! At the top of our priority list for this year are the contracts that are up for renegotiation in 2023. There are several that will be worked on this year, including the contracts at DeCicco's and First Student. Our negotiating team is hard at work preparing to deliver the best possible contracts for Local 338 members working in those shops.

We are also in the process of negotiating contracts for the farmworkers at Pindar Vineyards and Palmer and Paumanok Vineyards on Long Island. After over a year since they won their union election, we are confident that 2023 will be the year that these agricultural workers will finally have the strong union contracts they deserve.

2023 is yet another State election year, and I would like to remind our members of how important it is to exercise their constitutional right to vote! It is important to vote for candidates who will support working people in every election, but the recent controversy surrounding

United States Representative George Santos is an unpleasant reminder of how critical it is that we are thorough when vetting candidates running for office.

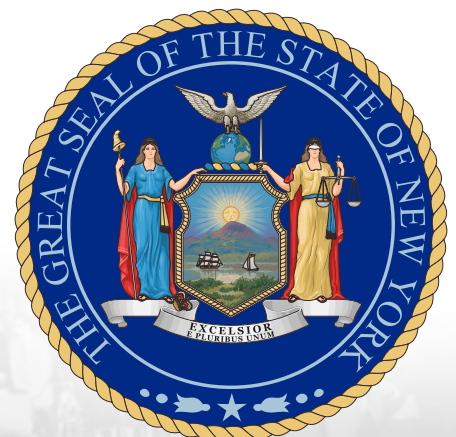
It is unacceptable that we have a representative who lied his way into Federal office, and we must do a better job in future elections to ensure that a candidate's resume is factual. As we get closer to the June Primary, you will be able to view a list of candidates running for office for several statewide and local seats in your Local 338 Member Portal. I encourage you to do your research and support candidates who are going to protect your rights as workers.

When we elect candidates that will fight for workers, we see the difference they make in the daily lives of everyday New Yorkers. Governor Hochul was one of these candidates, and her 2023 budget includes increases to the state's minimum wage, investments in education and renewable energy, a cost-of-living adjustment for direct service providers, and much more.

Her initial budget proposal is a good start, but Local 338 will be

advocating for increases in her proposed funding for the Facilitated Childcare Enrollment Project and the Cannabis Workforce Initiative, as well as an increase in the proposed cost-of-living adjustment for health services workers, which include our members at IAHD, IRI, and Community Resources.

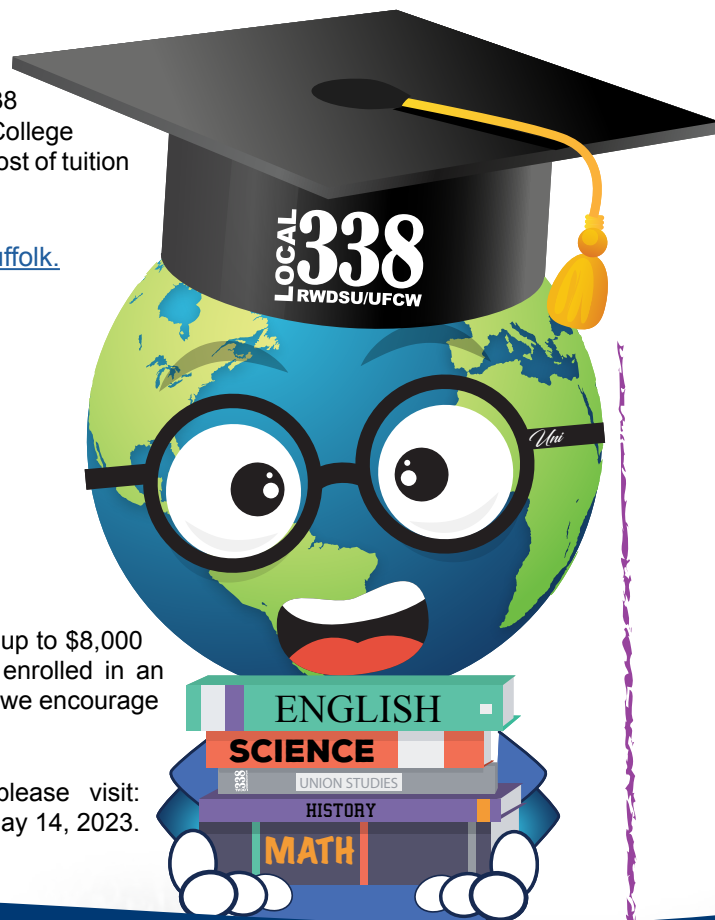

*Building a Cannabis Industry That Works for Everyone*

New York's adult-use cannabis industry is beginning to take off, and the first round of regulations for the adult-use cannabis industry were released in December by the Office of Cannabis Management (OCM). These regulations will serve as a guide for businesses and stakeholders—workers, advocates, community organizations and more—on what New York's adult-use cannabis industry should look like.

The release of the first round of regulations was followed by a public comment period that wrapped up in mid-February. The state received thousands of comments from those interested in owning cannabis businesses, community organizations, advocates, along with Local 338 and members working in the cannabis industry. The OCM must now review the comments and will use them to adjust the regulations for the next round that may be released at some point this year.

New York is in a unique position—we have the chance to build an industry from the ground up, and through the OCM's continued efforts to meet with industry stakeholders, we will ensure that New York's cannabis industry is one that uplifts working people and allows people from marginalized communities to succeed. The first round of regulations brings us closer to upholding the mission of the Marijuana Regulation and Taxation Act (MRTA), which was signed into law in 2021.

Local 338 has played an important part in setting the standard for jobs in the medical cannabis industry—we have ensured that workers receive fair wages, strong benefits, and have spent years working to ensure that the medicinal industry is one that supports working people. It is critical we maintain that standard for the adult-use industry and ensure that workers entering the industry have the same high wages, strong benefits and industry standards as the ones that have been established for New York's existing cannabis workforce.

The OCM is committed to creating a social equity program that creates opportunities for communities

that have been impacted the most by cannabis criminalization and prohibition. They value highroad employment, which will allow for these cannabis jobs to become reliable, unionized careers. The first set of regulations also protects the members of Local 338—the work of our membership cannot be outsourced, which prevents the standards we've set for the industry from being undermined. However, we believe that the good, quality jobs we've created and our members who participate in the medicinal industry should be able to grow with the industry as well.

The first set of regulations were a good-faith effort for what the industry can and should look like, but there is more to be done to ensure this is the best cannabis program in the country. Over the last year, we've seen thousands of unlicensed cannabis shops popping up across New York. We are not calling for the recriminalization of cannabis, but the State must also prioritize enforcing unlicensed cannabis shops across the state, along with getting licensed dispensaries open to the public. This will be critical in ensuring that CAURD and social equity dispensaries have the best chance at success, we're promoting public and worker safety, and that tax revenue is being generated to support all of the intended community reinvestment programs. We are also fighting to ensure the survival of the medical cannabis industry and are pushing for an investment in the industry, which provides essential care for thousands of patients and employs hundreds of New Yorkers across the state.

I would like to thank the Local 338 members who have participated in the process of reviewing and commenting on the first round of cannabis regulations. Your feedback and conversations with the OCM are going to help build an industry that supports working people, and it would not be possible without your commitment to the industry. We are looking forward to the next round of regulations and your cannabis representatives will be able to walk you through them when they're released.



# Welcome to the Union Cannabis Family, Housing Works Cannabis Co.!



The first adult-use cannabis dispensary in New York officially opened on December 29th, and we are proud to announce that it's staffed by workers who are members of Local 338! Housing Works Cannabis Co. is an extension of Housing Works, a non-profit working to fight HIV/AIDS and homelessness throughout the city. In addition to the dispensary, Housing Works runs thrift stores and bookshops across the city, along with working in harm reduction.



The opening of the recreational-use dispensary marks an exciting milestone for New York's adult-use cannabis industry! Adult-use cannabis was legalized in 2021 with the passage of the Marijuana Regulation and Taxation Act, after Local 338 and other advocates spent a decade fighting for the drug to be decriminalized and legalized.



When you shop at legal, unionized adult-use dispensaries, you're guaranteed a product that has been tested and processed by industry experts. You can trust that what the cannabis you are purchasing is safe to consume and dispensary staff will be able to answer any questions you have about using the product! To shop union adult-use cannabis, you can visit the Housing Works Cannabis Co. at 750 Broadway in Manhattan.



We now represent 100% of the workers in New York's medicinal industry, and we are hoping to emulate that in the adult-use industry. We want every worker to have a chance at a good, union job with wages and benefits that will allow them to support themselves and their families. By unionizing the workforce in the medicinal cannabis industry statewide, we are setting the standard for cannabis jobs statewide, ensuring working people will be able to rely on their cannabis careers—in both the medicinal and adult-use industries—for years to come.



We expect this year will bring the opening of several more adult-use businesses across the supply chain, and we are hard at work fighting to ensure that New York's cannabis industry is the most pro-worker cannabis industry in the country. ## MEMBER SPOTLIGHT

### Member Benefit Spotlight: Luis Roldán

When Luis Roldán attended a routine Local 338 membership meeting where the Guardian Nurses were giving a presentation, he never thought he was going to need the benefit.

"I said, 'well I'll never use this service, I'm healthy.' And a year later, boom," he said. Luis had to have major heart surgery and immediately called Guardian Nurses to be with him throughout the process.

Luis Roldán has been a full-time member of Local 338 since 2015 and works in the deli department as a chef at the Morton Williams on Bleecker Street in Manhattan, where he prepares food for catering orders, the hot bar, and showcase.

Guardian Nurses is a benefit offered to members and eligible dependents of Local 338's Health & Welfare Fund and Crossroads. They are nurses and patient advocates who will help you navigate the healthcare system, serving as a support system as you take steps to maintain your health. The Guardian Nurses will help you find the right in-network provider, attend appointments with you, ask questions on your behalf, and visit you in the hospital after a procedure. Luis says that having the nurses at his side throughout the entire process made it all much easier.

"At the time, Andrea was the nurse who was assisting me, and she was just fantastic. It was a very scary time in my life, and she helped me navigate the whole process. Andrea talked me and my family through it and came to see me when I was in the hospital. Andrea and her coworker Michelle have been following up with me since my procedure," Luis said.

Having someone with him who was able to explain what was going on and answer questions was a huge comfort, Luis said. When you're going for a major procedure or have just gotten a scary diagnosis, having an expert with you who will be able to walk you through the process of getting ready for surgery or other treatment to manage a condition makes a huge difference.

Luis wants to encourage members to familiarize themselves with the benefits that are offered to them, because you never know when you may need them.

"Look into what benefits you have that can help you and your family. Look into all of the options that Local 338 has for us, because the services are excellent, and they're there to help you when you are navigating a medical setting," he said.
