You've all had to adjust to new workplace procedures while facing the very real fear about bringing the virus home. However, your commitment and dedication to what you do was and has been vital in ensuring the general public continues to have the goods and services they need to do their part in keeping the number of cases low, which is critical as we enter the winter months and a second wave of COVID-19.

However, despite all of the chaos, there have been a number of incredible developments this year. We've endured a traumatic time for the labor movement. now we can look forward to attaining real and lasting progress for working families.

The pandemic isn't over, but with a vaccine on the horizon, we can see the light at the end of the tunnel, but a full recovery is still a way off. We will need to work together more than ever in the new year to bring change to our state and country. While New York State faces a serious financial crisis, Local 338 will fiercely advocate to retain essential government services for our members, while continuing to advocate for adult-use cannabis legalization to create new union jobs and generate much needed revenue for our State. In the meantime, we will continue fighting for your hard-earned hazard pay, guaranteed and unlimited PPE, affordable, quality childcare for essential workers and priority attention

during vaccine distribution. The needs of our members and your families will be heard in the halls of government. However, we cannot do it without you and I encourage you to consider getting involved with our political and legislative work in the new year.

We have witnessed heroism emerge from unexpected places and 2020 was the year of you, the essential worker. From grocery store workers lending a compassionate ear to their regular shopper who was struggling, to our direct care givers going the extra mile to ensure their clients are healthy and safe, our membership have taken on responsibilities which strengthened your communities during desperate times. As your President, I will continue fight to ensure our employers, elected officials and community leaders always remember your sacrifices and the risks you've taken during this global crisis. Your work has always been vital, and it will continue to be, pandemic or not. The public and public officials, from the President-Elect down to our Governor and local elected offiicals. have publically acknowledged the strength and determination of all Local 338 essential workers.

As we reflect on a challenging yet momentous year, we should resolve to continue caring for our communities and expressing love to our families. On behalf of the entire Local 338 family, I wish you and your loved ones a happy holiday.















Joe Biden is set to become the 46th President of the United States. For the first time in four years, working people will have an ally in the White House. Biden has consistently shown up for working people, including last year when he came to speak at a UFCW rally in support of Stop & Shop workers who were on strike throughout New England. Throughout his campaign, Biden has vowed to be the most pro-labor President we've ever had and has developed a plan to strengthen the rights of working people in the United States.

Under Biden, it will be easier to join a union and corporations will be held accountable when interfering with the unionization process. He has begun to assemble his White House team, which includes several people with ties to the labor movement or have fought for working people in the past. His policies will include farm and domestic workers for the first time and allow independent contractors—like those working for gig companies to have the right to organize. Biden has also recommitted to his campaign pledges to support both essential workers and workers who have been impacted by COVID-19 related layoffs, through meaningful recovery programs.

The new Administration's plans don't just impact working people in their workplaces. He has also proposed plans that expand access to quality and affordable childcare to reduce the stress so many working parents face. Other policies include reducing the burden of student loan debt on young people entering the workforce and protecting pension and retirement plans for workers who are ready to retire. His Transition Team is also working on addressing racial inequality in our country through comprehensive reforms in areas like criminal justice, education, and housing.

Biden's victory is a win for the labor movement as he has already begun to fight for the working Americans. His election wouldn't have been possible without union voters like you, so we wanted to say thank you for helping get out the vote and making sure the voices of union members across the country were heard!

However, our election related work is not over just yet. On January 5, 2021, there will be a runoff for two Senate seats in Georgia and the outcome of this election will determine who controls the United States Senate. This is particularly critical as the current Senate, led by Majority Leader Mitch McConnell, refuses to negotiate, let alone vote on much needed COVID-19 relief and recovery legislation. We will be partnering with the RWDSU and AFL-CIO to help turn union members out to the polls over the coming weeks. On behalf of Local 338's Member Assistance Program, I would like to wish all our members a Happy Holidays! The holidays are always a complicated time of year where we're either excited to see relatives we haven't seen for months, or we're rushing to get everything prepared for guests and gifts – emotions run wild! Unfortunately, we are going to be doing things a little differently this year.



CDC guidelines suggest we skip the usual holiday gatherings to help prevent a possible unmanageable spread of COVID into our homes. Look at it this way - we are apart this year so we may spend the following years together! It's a hard reality that we have to face, but we make this sacrifice in order to ensure the health and well-being of those more vulnerable than us, like our parents or grandparents. For many, the holidays are already a lonely time, now we can appreciate the lives of our loved ones and experience the holidays in solidarity.

You can always decide to go virtual! FaceTime, Skype or Zoom offers a safe way of staying in touch this year. Everyone's actions have a direct impact on the progression of the virus in our communities. Please be mindful of your actions for your sake, and everyone else's sake as well. Many people are forced to change their plans this year. We're all making difficult decisions in rescheduling weddings, anniversary and birthday celebrations or completely restructuring how family gatherings work. Celebrations have turned from a loving, warm experience to one that can be very stressful and overwhelming. However, there are a number of coping mechanisms you can take advantage of to ease your mind. You can volunteer to help others in your community in order to retain that feeling of holiday cheer, express your gratitude by sending meaningful cards to family members or friends or schedule a weekly virtual family toast. Above all, make a conscious effort to sleep well, eat right, exercise, laugh, and get emotional support from your loved ones to maintain your emotional health.

The holidays often expose very serious mental health triggers for certain individuals, and we know that this year may be especially challenging. What To Do If You Test Positive



As of December 1st, 2020, 63 million people have tested positive for COVID-19 around the world. Of those millions, approximately 20% will not experience any symptoms (asymptomatic). The vast majority (80%) of positively tested individuals will experience often uncomfortable and potentially serious symptoms. While an overwhelming majority of people have since recovered without any long-term complications, COVID-19 is something we must all take seriously, especially as cases are once again on the rise.

What happens should you test positive? First, you should make a list of everyone you've physically seen in the past 14 days and let them know they may have been exposed to COVID-19. They should get tested as soon as possible as to prevent further spread. People tend to be very understanding and grateful you've let them know. Regardless, it's the right thing to do. Second, let your supervisor and Union Representative know you've tested positive.

It takes a few days for the virus to start affecting the body. Some common symptoms you should expect are headaches, body aches, temporary loss of taste or smell, frequent dry and unproductive coughing, fever or chills, sore throat, fatigue, and loss of appetite/nausea. Local 338 employers vary their paid time-off (PTO) policies differently. Check with your Union/Funds Representative to fully understand your employers PTO policy before taking any action.

As a member of Local 338, you are eligible for health-related benefits, depending on your contract:

- During this unprecedented time, Guardian Nurses will now be available to assist part-time Local 338 members (previously only available for eligible full-timers) with questions or concerns regarding COVID-19. They will provide support and coordinate care for Local 338 members, such as locating testing sites for COVID-19. We have two nurses available from Guardian Nurses to assist you: Andrea can be reached at 484-684-0039 and Jasmin, who is also bilingual, is available at 718-354-6605.
- **TelaDoc** is a free service available to all eligible members and immediate family members. By calling 1-800-835-2362, you can speak with a licensed medical professional regarding your symptoms with 24/7 access. You will be able to speak with a doctor who can diagnose your condition and, if necessary, prescribe medication to be picked up at your local pharmacy immediately. While there is no copay for TelaDoc, this benefit is only available for Local 338 members enrolled in the Health & Welfare Fund.

When you get your positive test result, it's important not to panic. Millions have tested positive, suffered uncomfortable symptoms for a while and then completely recovered. Treatments have improved since the beginning of the pandemic. Pay attention to your symptoms and be sure to check in with your doctor. Rest and expect your most uncomfortable symptoms to be over in about 6-10 days or less. Stay strong - the end is in sight!















Benefits to Help with Your Health

As members of Local 338, you are faced with the challenge of providing for both your community while at work, and your family when you come home. Your health and peace of mind is our top priority. Below are two benefits available that might be available to you that are intended to support your health and help you save money.



For Local 338 members (and their eligible dependents) who are enrolled in the Health & Welfare Fund, the Livongo for Diabetes Program is available to help make living with diabetes easier. The program provides a connected meter, unlimited

strips and supplies, as well as personalized health tips and coaching. When you run out of testing strips and lancets, Livongo will ship the supplies right to your door. Livongo diabetes coaches are available anytime you need them via phone, text or mobile app to give you guidance on your lifestyle for an easier experience. These services are available free of charge!

The Hospital Income Replacement Benefit

If you're expecting a baby, have to have an outpatient medical procedure, or had a recent stay at the hospital, the Hospital Income Replacement Benefit is here to give you a little peace of mind. As a member of Local 338, you won't have to worry about loss of income from missing a day's work should you need certain kinds of medical attention and care.



This benefit provides for replacement of lost income due to a doctor-ordered hospital stay from an injury, illness or procedure. The benefit also provides for replacement of one day of income if you are unable to work for more than one day following an outpatient surgical procedure, not including the day on which the surgical procedure occurred. The plan pays benefits directly to you, up to a certain maximum depending on your specific benefits plan. Please note that this benefit is available to Local 338 part-time members who are enrolled in the Benefits Fund.

We here at Local 338 strive to be innovative in the benefits and programs that we offer to our hard-working members. Should you have any questions about any of these or other benefits you're eligible for, please do not hesitate to give our office a call at 516-294-1338 ext. 1776. We are pleased to announce that this year's Local 338 Charities Inc. Scholarship Awards Program is now open to Local 338 Members (and their dependents). To be eligible, applicants must be active members of the Union and have been for at least one (1) year from the date the Short Form Application is due on March 19, 2021. Please note this scholarship program is open to students who are currently enrolled as High School Seniors or currently enrolled in college or trade/vocational school.


The Scholarship Awards Committee reviews all completed applications and awards a number of individual scholarships, including:

- The Emanuel Laub Scholarship which awards \$2,000 a year for all four years of college in annual installments (totaling \$8,000),
- One-time Scholarship Award of \$2,000 for students attending college, vocational training, or other accredited institution,
- The Continuing Education Scholarship Award which is a one-time award of \$2,000 for students pursuing a continuing education program, master's degree or doctorate degree,
- And The Book Award Scholarship, a one-time award of \$500 to be used towards textbooks and course materials.

To receive one of the Local 338 scholarship awards, the applicant or their guardian must remain a member in good standing until the scholarship is awarded.

The deadline to submit the Short Form Application is March 19, 2021.

Please supply the following information accurately, making sure to include the member's Social Security number or member ID number (RWD#). When the Short Form Application is received by the Scholarship Awards Committee, a Long Form Application will be sent to the applicant. (All completed Long Form Applications and supporting materials are due April 16, 2021.)

As a member of Local 338, you have access to a variety of different scholarship opportunities for you or your qualifying dependents. Applications are now open for several scholarships, including the following:



Union Plus offers a Bachelor's Degree Completion Program, which gives members the opportunity to complete their bachelor's degree at little to no cost. Class enrollment is on a rolling basis, so visit our website for more information on how to get started! Union Plus also has a scholarship program of their own, which awards between \$500 and \$4,000 to students whose study begins in the fall. The deadline to apply is January 31, 2021.





Local 338 offers two scholarships for students attending Nassau or Suffolk Community Colleges. Eligible students are eligible for up to \$2,000 towards the cost of tuition per semester. These programs are open to members and their dependents and is renewable if certain GPA criteria is met. These deadlines occur on a rolling basis, so please check our website for details.

You May Be Missing Out on **Thousands of Dollars Towards the Cost of Childcare!**

As a union member you may be entitled to funding assistance through the Union Facilitated Childcare Enrollment Project, which provide funding assistance to help ease the high costs of quality childcare for working parents. Many Local 338 members have already been approved for the program and received thousands of dollars towards the cost of day care and after school programs for their children. In fact, over the last few years, almost \$400,000 has been distributed to Local 338 members!

How Does it Work?

If you work at least 20 hours per week, have children under 13, and meet certain geographic and income requirements you might be eligible to apply for a subsidy to apply to the costs of childcare.

How Do I Know if I'm Eligible?

If You Live in New York City:

If you live within the Five Boroughs, you can verify your eligibility and start the prescreening process,

by visiting: local338.org/childcare

If You Live in Upstate New York:

If you live in Albany, Erie, Monroe, Oneida, Onondaga, Rensselaer, Saratoga, or Schenectady Counties, you can verify your eligibility and start the pre-screening process, by visiting: wdiny.org/childcare

Please note that if you qualify for the program, you will be contacted by our partner organizations who will guide you through the full application process.
