While Presidential and Congressional elections are incredibly important, local elections for State Legislative races deserve just as much attention. State and municipal officials you elect determine the outcome of many issues that have a direct impact on you, your family, and your community. As an example, the hardworking Local 338 members at IAHD and Community Resources care for individuals with developmental disabilities—a job that is incredibly important in our communities! Both of these agencies are funded solely by the State of New York. Each year, as part of the

State budget, the legislature determines whether or not to fund pay increases or Cost of Living Adjustments (COLA) for these hardworking men and women.

The Importance of Your Shop Steward

As a member of Local 338, you have a special advantage that non-union workers do not have: Weingarten Rights. Weingarten Rights entitle you to representation during grievances or meetings with your employer when there



is a disagreement in the workplace. Your Shop Steward holds a special place in this process. Their role is to act as an

extra set of eves and ears and participate in discussions as a witness. This voluntary position is an extension of Local 338 that ensures you have someone supportive on your side to uphold your union rights.

We recently held a training conference to educate your workplace's Shop Steward about how to help when needed. We discussed the proper steps to take when there is a grievance including, but not limited to, preventing you from making self-incriminating

statements. We also advised your Shop Steward about the importance of acting as a witness to ensure your employer is in compliance with laws and regulations that guarantee safe working conditions and how to effectively monitor and enforce



your collective bargaining agreement as well as answer questions you may have about your contract.

Your Shop Steward is an essential part in maintaining

healthy communication between Local 338 and you, our members. We want to thank our Shop Stewards for



another great conference, your support of the Union, and your tremendous dedication to help your fellow coworkers and members!



Workers of America (CWA) and the International Brotherhood of Electrical Workers (IBEW) returned to work. It took over 11 months of negotiating and 45 days on the picket lines, but finally the ordeal was over. The strike sent an important message to corporate America that union workers will stand up for what they believe in, and stay strong in the face of unfair management demands.

Throughout the country,

RWDSU members stood with the Verizon Strikers, including Local 338 members on Long Island. We marched with them on the picket lines because we know that together, we are stronger. Here in New York, workers are using their union voice to create better jobs and better lives.

We see that strength throughout our union. We see it in the car wash campaign that since 2012 - for the first time - has brought

union benefits and protection to hundreds of car wash workers in New York City. We saw it over the summer, when thousands of Macy's workers stood together against management demands for concessions and givebacks by winning a strong new

contract. And we see it in New York's new marijuana industry,

where workers including pharmacists and pharmacy technicians, growers and trimmers and others on both the manufacturing and retail sides of the business are winning the right to be

Local 338. And we saw it this summer at Zara, the world's largest fashion retailer. Workers at Zara's eight stores in Manhattan have joined the RWDSU. These 1,000 workers are the first Zara workers in the United States to be unionized.

Benefits You Don't Know You Have and Are NOT Using!

If you're a member eligible for benefits through the Local 338 Benefits Fund, you likely know already that you have dental, optical and death benefits. And if you're a member that's also eligible for the Local 338 Health & Welfare Fund, then you likely know that you have medical and prescription benefits, too. But too many members are not using other benefits offered through those Funds, and we're pretty sure it's because many of you are not aware of them or how valuable they can be for you. Here are two great benefits that you might be eligible for as a participant of the Local 338 Benefits Fund.

We encourage you to take advantage of them!

Local 338 Child Care Benefit

Very few members have applied for the Local 338 Child Care Benefit. This benefit is open to members who are eligible in any of our Benefit Fund plans – so it's available to full-time members and part-time members – and it's open to you for your children from birth up through 12 years of age.

It applies to both child care provided by licensed child care centers or after care programs through schools, and to child care provided by anyone else, like your neighbor, friend, relative (other than your spouse).

How much your benefit is depends on:

- · How many children you have in child care,
- Whether it's documented or undocumented child care, and
- Your income.

The maximum benefit is \$1,600 per year. We recognize that's not a large amount, but, even \$100 in your pocket is better than \$0!

We encourage you to apply, which you can do by calling the Fund at 516.294-1338, ext. 1299.

Hospital Income Replacement Benefit

Think of the Hospital Income Replacement Benefit as being our version of a mini-AFLAC plan. This is a member only benefit and is available for part-time members only. If you are admitted to the hospital, we will pay you either \$250 per day (Plan 1B) or \$150 per day (Plan 2B), depending on which Plan you have, for up to 10 days per calendar year.

This benefit is available ONLY to part-time members because under the Affordable Care Act we can no longer provide medical benefits to these members, like we do for full-time members. As an alternative, we looked for a benefit that would be of value to our part-time members and would help supplement whatever health insurance plan that they may have now.

To access the benefit, you just have to send the Fund Office a copy of your hospital bill so we can see how many days you were admitted.

So PLEASE, spread the word about these benefits!



Dr. Albert Barrette, the leading physician at Inner Imaging with 30 years of experience, believes

this scan is the best way to catch illnesses before they develop into more serious and untreatable diseases. He uses The Electron Beam Tomography (EBT) Scanner which has the capacity to detect 116 diseases including Heart Disease and 11 forms of cancer. "This thorough imaging test can reveal even minor problems that often cannot be detected by physical examination, EKG, or even a Stress Test," said Dr. Barrette. Other than early detection of Heart Disease and cancer,

the scanner can also detect other diseases like asbestosis 8 years before it would show up on a

regular x-ray!

WE'RE HERE TO HELP!

With alcohol so easily accessible, it is easy to overlook when you or someone you know is experiencing an alcohol problem. Alcohol abuse has long-term and short-term effects. If left untreated, alcohol abuse can lead to numerous physical problems, such as chest pain, damage to your liver or kidneys, migraines and even hallucinations. Alcohol abuse can also lead to drinking and driving, endangering one's own life and that of others. It could also very well lead to legal consequences, including suspension of your license, mandated treatment, jail time, confiscation of your vehicle, suspension from your job, and legal fees. Short-term effects of alcohol abuse may include financial problems, injuries and poor decision making which can impact your job and home life.

How would the MAP program help me if I had a problem with alcohol?

First, remember that every issue brought to MAP, including alcohol and substance abuse issues, are kept strictly confidential. If you're having an issue with alcohol, it is in your best interest to reach out and ask for help. A Local 338 member, Bob*, tells his story:

"I had always considered myself a hard worker, showing up on time and doing all the right things in the shop. My manager and coworkers were always able to rely on me. I was never late and never missed work. Customers would describe me as easy-going and helpful. After my daughter was diagnosed with cancer, I started to drink to cope with the stress. I soon started calling out of work and missing my shifts because I was too drunk to come in. When I did come in, I was late, distracted and uninterested in talking to anyone, especially customers. I started to frequently get written up for my behavior. I realized that my drinking was putting my job in jeopardy, so I contacted my union representative who got the MAP program involved. Jennifer, the MAP Director, was able to assess what was going on, listen to my personal problems at home and direct me to a substance abuse treatment facility so I could get the help that I needed while keeping my job. I was ashamed of my drinking and my behavior, but through the MAP program, I was able to ask for help without feeling judged or risk losing my job. Thank you for your help, Local 338 and MAP!"




Talk to a Doc **Around the Clock!**

Teladoc provides you with 24/7/365 access to a doctor through phone or video consults at absolutely no cost! You can easily sign up online, over the phone, or with the mobile app like Steven did. He first used Teladoc when he was on vacation with his family in another state. When he noticed his son had a rash, he feared that he couldn't find a doctor in the area, but he was able to use the Local 338 Teladoc Benefit.
