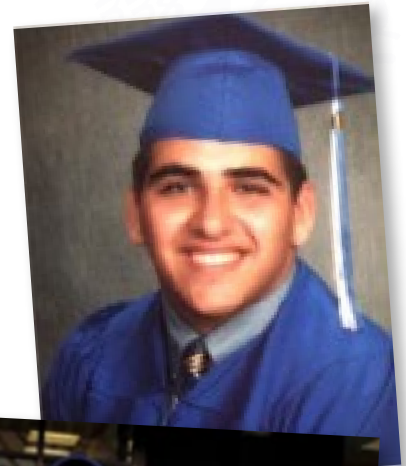

LOCAL 338 CHARITIES, INC. SCHOLARSHIP AWARDS PROGRAM

The 2017 Local 338 Charities Inc. Scholarship Awards Program has been expanded starting 2017! The changes for 2017 include the following:

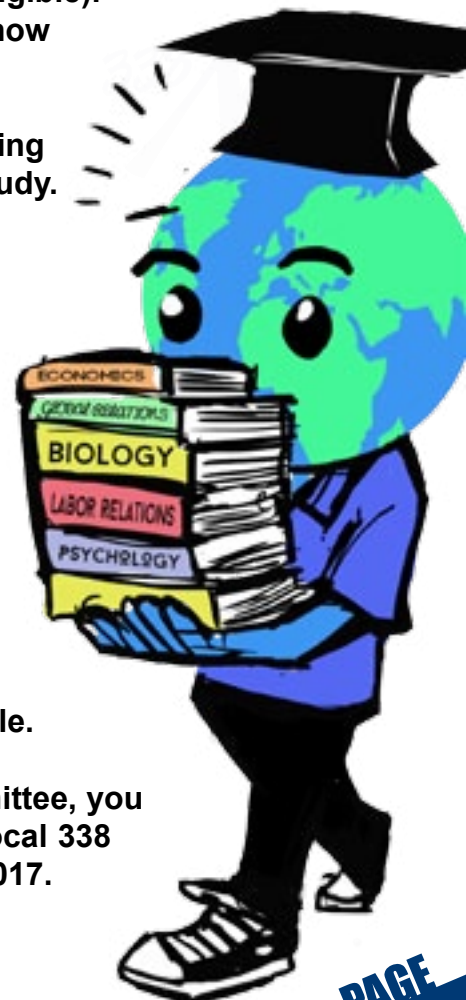
- Dependents of members are now eligible if they graduated high school not just in 2017, but as long ago as two years prior to the year in which the scholarship is awarded (Applicants who are currently enrolled as college students are not eligible).
- And for members who are applying, there is now no restriction to how long ago you may have graduated high school.
- The Book Awards have been increased from \$250 to \$500.
- And scholarships are available not just to those who will be attending college but any accredited educational or vocational program of study.

The Scholarship Committee reviews all applications and awards:

- One individual with the Emanuel Laub Scholarship which is \$1,500 a year for all four years in annual installments (totaling \$6,000);
- 10 individuals with a one-time award of \$1,500 for their first year of continuing education or training; and
- 10 individuals with a Book Award Scholarship, which this year has been increased to \$500 each.

You or your parent must have been a member of the Union for at least one (1) year from the date of the award to be eligible to apply for the scholarship and remain a member until the scholarship is awarded. Applicants who are currently enrolled as college students are not eligible.

When the short form application is received by the Scholarship Committee, you will be sent a long form application, which must be returned to the Local 338 Charities, Inc. Scholarship Awards Committee no later than April 14, 2017.

Standing Strong

This past year often felt like one of the most divisive times in recent history. But I think it is vitally important to remember that what unites us Americans – and particularly, us as union members – is much greater than that which divides us. Our values remain strong, and as a union we are as committed as ever to fighting for the interests of members, to protecting the gains we have won in our contracts and to winning even better working conditions.

We can continue to make progress if we stay united. We cannot let fear and uncertainty deter us from our mission. We must come together to build on what we have accomplished in recent years and fight to reach our goals in 2017 and beyond.

Unions and workers have won many battles over the years by standing together against the odds – and we in the RWDSU have seen some great successes here in New York.

We are especially proud of winning the Grocery Worker Retention Act in New York City, which will protect supermarket workers from immediately losing their jobs when stores change hands.

Because of our success in getting

that Act passed by the City Council and signed into law by Mayor Bill de Blasio earlier this year, workers are guaranteed at least a 90-day grace period rather than faced with sudden financial upheaval and instability while trying to support themselves and their families.

Now we will turn our focus to Albany, where we will fight for a statewide Grocery Worker Retention Act to protect food store workers from the heart of Buffalo to the tip of Montauk.

We also are proud at having won a strong new contract for our 5,000 members at Macy's that includes wage increases, better health coverage and fair scheduling. And this past year we also won union rights for 1,000 workers at eight Zara stores across the city when they became part of our union.

Just recently we worked to get a bill introduced into the New York City Council to ban on-call scheduling for retail workers by prohibiting employers with five or more workers from cancelling or changing an employee's shift without 72 hours notice.

On-call scheduling is particularly onerous and hard

on workers in terms of stability and predictability. A recent Community Service Society report found that workers with unpredictable schedules have a harder time managing work and family responsibilities and even paying their rent or other bills.

Though 2017 will be a challenging year to be sure, we are confident that we can continue to make progress. We will not rest on our laurels, but pledge to work even harder on behalf of all workers in grocery stores, department stores, retail shops and car washes. All of us working together can continue to make a real difference for the members of this union.

Moving Forward After the Elections

While the outcome of this year's election was shocking and disappointing for many, the election is over and Donald Trump will be the next President of the United States. While many people found the things that Donald Trump said and did throughout his campaign offensive and frightening, we must find a way to move forward as a nation. The fact is, the nation's success is tied to the success of our President. The decisions made by his Administration will, without a doubt, affect every one of us as working men and women. We must come together as working Americans and fight for the issues that matter to all of us.

While the 2016 election was more of a reality TV show than a campaign, the Presidency is not a game or a show. It is an official position that will impact millions of working Americans and their families. Unfortunately, come Inauguration Day, some fundamental longstanding policies designed to protect workers will fall into question. Important issues such as appointments to the National Labor Relations Board, funding for the Occupational Safety and Health Administration (OSHA), our ability to depend on Social Security & Medicare when we retire, and our fundamental right to collectively bargain may be attacked or weakened by the new Administration.

The first sign of trouble for working Americans was the President-Elect's nomination for Secretary of Labor. He has chosen Andy Puzder, CEO of the fast food chains Hardee's and Carl's Jr., to fill that position. The Labor Secretary is supposed to be an advocate for working Americans and represent

their voice within the Federal Government. Unfortunately, Mr. Puzder seems to be the opposite of that. He is a champion of Corporate America with a long history of anti-worker and anti-union beliefs. He opposes any increases to the minimum wage, does not support a worker's right to join a union, opposes low-wage workers' rights to earn overtime pay, and also believes in the use of automation to reduce the need for workers.

The nomination of Mr. Puzder is just the first of what many expect to be a wave of anti-worker appointments and policy to be seen over the next few months. Now more than ever, we as working Americans need to be ready to fight for our rights, benefits and livelihoods. It is not just rhetoric: we must be active, we must be involved and we must stand up for ourselves, and all working people, once we come under attack. The first step is to ensure that that you are registered to vote (click below to register), but that really is just the beginning. When you vote, your voice is counted; when you attend lobby days, your passion is demonstrated; when you contribute to the Local 338 PAC, your concerns can be addressed; when you are involved in any way that you can be, you make the values of all working people known.

Are You Facing Eviction?

The Member Assistance Program May Be Able To Help!

It is no secret that living in New York State is expensive. With housing expenses on the rise, many New Yorkers find themselves having a hard time keeping up with housing costs. Unfortunately, it is not just members of Local 338 who struggle with housing. Many people find themselves struggling to make monthly bills and mortgage or rent payments. If we let the payments pile up long enough, we often find ourselves facing eviction with no place to go. With the colder months coming, it is harder to ignore the severity of homelessness and we recommend that you be proactive if you are facing eviction or other housing emergencies.

How Could The Member Assistance Program (MAP) Help Me If I Had A Problem With My Housing?

First, remember that every issue a member brings to MAP is voluntary and confidential. Emergency housing resources are the most requested resource that MAP receives. This proves that you are not alone in your situation. Second, MAP CANNOT guarantee rental assistance. If you are facing eviction, loss of your home due to fire or another type of housing emergency that leaves you without stable shelter, we can walk you through the process of applying for assistance through New York State and other resources in your community. We can also provide you with information on where you can get help with budgeting your expenses so that you can pro-actively avoid future housing issues.

How Has MAP Helped Other Local 338 Members?

Erika* had two part time jobs, never missed a day of work and was always conscientious of her monthly bills. She did everything she could to keep up with her monthly payments, but still was unable to make her rent payments. After six months of being unable to pay rent, she received her first eviction notice. Erika was scared and didn't know what to do. Her coworkers noticed her sleeping in the break room and carrying around more stuff than usual. She was referred to MAP where she was given resources to shelters, eviction prevention, and debt counseling. Erika worked with the MAP Director and her resources to find more financially stable options in her community, which in turn prevented her from becoming homeless.
