# DREAMers Should Have the Chance to Pursue the American Dream

Deferred Action for Childhood Arrivals (DACA) has protected hundreds of thousands of young adults who were brought to the United States by their parents as children. Due to their age when they immigrated, they cannot and should not be held accountable for violating any laws. When DACA was passed in 2012, these young men and women were given the opportunity to get drivers licenses, attend school, obtain good jobs, and purchase their first homes. Through this program, these young men and women have gained the confidence to chase the American Dream, a dream that all of our ancestors had when they

arrived in the United States, too.

DREAMers have worked tirelessly to better their lives and the lives of their families, and there is no justifiable reason why they should be punished for a decision that was made when they were infants or young children. If DACA is taken away from these recipients, they will live in constant fear of deportation to a country that is not theirs. America is the only country they have ever known. They may have no recollection of their place of birth, and for many, English is their first and only language. Threatening to remove 800,000 people from the workforce and out of the country that they have called home since they were children is a threat to the integrity of our country and all that it stands for. DREAMers have been raised here in the United States and have grown to be successful and productive members of their communities. They do not have criminal records, attend college, and have fought bravely in our military. DREAMers have been raised as proud Americans just like you and I.

Ending DACA would also have a devastating impact on our national and local economies. DREAMers are in fact tax-payers, many of whom own homes with mortgages, and some of whom even work for prestigious Fortune 500 companies. We will lose billions of dollars without their contributions to our economy. Employers will also lose a very important asset; their skilled and hard-working employees.

These are just a few of the reasons why we must not simply fight back against the Administration's plan to end DACA, but rather, fight for legislation that will protect the DREAMers and put these hardworking men and women on a path to citizenship through the DREAMAct. This legislation would grant permanent legal status to these young adults who were brought here as undocumented immigrant children as long as they meet certain requirements. These young men and women should not have to live in fear of a decision that could tear apart their lives and families at any moment. We must show our unity in support of the DREAM Act to preserve the American Dream for all, to be that shining light on the hill, and to continue to be the land of not only the free and the brave but of compassion and hope.



# THE CONSTITUTIONAL CONVENTION WILL HURT WORKING FAMILIES VOTE NO on November 7th

In addition to voting in many important local elections, you will be casting a vote on "Proposal #1," which will be on the reverse side of your ballot. Here are a few things to know about the Constitutional Convention before you head to the polls.

#### It Puts YOUR Rights at Risk

A Constitutional Convention will give special interest groups the opportunity to make changes to the rights and protections, like workers compensation, that hard working men and women have had for decades. These wealthy special interest groups will put their agenda ahead of yours, making changes that benefit themselves and leaving New York families to deal with the impact on our safety, the environment and our schools.

#### It's a Waste of Our Tax Dollars

There is no agenda or projected timeline for how long the Constitutional Convention could last. Additionally, elected officials serving at the Convention could make up to \$80,000 on top of the taxpayer-funded salaries they already receive. A Convention could cost taxpayers hundreds of millions of dollars, which, could instead be used for other important programs and services.

Working People Could Lose the Right to Fight For Better Wages and Benefits

New York is one of the only states that explicitly includes the right to collectively bargain for a union contract in its State Constitution. If there is a Constitutional Convention, protective language could be eliminated, making it much harder for your union to negotiate a good contract on your behalf.

On Election Day, remember to turn over your ballot and vote against the Constitutional Convention by voting NO on Proposal #1.

# Local 338 Standing with IBEW Local 3 Spectrum Cable Workers

Since March, our IBEW Local 3 brothers and sisters have shown strength and solidarity by going on strike against Spectrum- Charter Communications. The company has threatened to reduce their pensions and healthcare benefits, something these dedicated men and women have earned. Nearly 2,000 workers voted to go on strike and have remained on the picket line ever since, resisting Spectrum's attempts at union busting.







The workers have successfully held two solidarity marches across the George Washington and Brooklyn Bridges and had the support of their union brothers and sisters. Governor Cuomo was at the Brooklyn Bridge

walk as well, putting pressure on Spectrum to negotiate a contract for New York's working men and women.

We will continue to support them until Spectrum agrees to work with Local 3 and negotiate better lives for their workers. It is important now more than ever that we continue to stand with Local 3 and the hardworking men and women they represent. We cannot allow Spectrum's corporate greed rip away at workers' protections and benefits.

# Do Beller BEST YET!

On August 9th, six hardworking men and women spoke out about the issues they face working at Best Market. Mike Thomas, Diomedes Mosquea, Dave Ness, Diane Motylenski, Angel Padro, and Marian Meszaros were surrounded by union members, community advocates and faith leaders as well as Suffolk County Legislator Sarah Anker. We all joined together to let Best Market know that we are one, we are strong, and we will not stop fighting until Best Market's workers get the wages and benefits that they deserve.





Each of these men and women shared their stories of the poor working conditions that they see each day at their workplace. They spoke about their low wages, how they are forced to pay as much as \$200 per week for their healthcare coverage, and unstable hours despite their many years of experience working in the grocery industry!

Legislator Sarah Anker offered encouragement to the Best Market workers to keep fighting. She insisted, "This is about your lives and your families, if there is money being made in a corporation, it needs to be passed down. You need to fight for better wages, it's only fair."

The hard working men and women at Best Market deserve a living wage that they can raise their family on and stable hours so they know what their paycheck will be week to week. These workers provide the service that allows us to put food on our tables, but struggle to do the same for their own families. It is time for Best Market to do better by their employees by offering livable wages and benefits to the men and women who work to make their business a success.



### Who We Elect Matters!



In mid-September, the United States Supreme Court accepted a case called Janus v. AFSCME Council 31, which threatens to make the entire public sector "right-to-work."

As you may remember from previous editions of 338 News, "right-to-work" (RTW) is legislation that is deceptively named, and its sole purpose is to weaken your power as a working person. Currently, 28 states have passed this legislation under the guise of doing the right thing for working people. Unfortunately, it has done everything but that. Based on the statistics, it is clear that "RTW" is the creation of well-funded, big businesses and is designed to take away from everyday working men and women by influencing politics.

In the past, a similar court case arose against three other public service unions as well—including Friedrichs v. CTA just last year, which ruled in the favor of unions. While we have remained strong, our fears of national RTW becoming a reality have never been as frightening as they are today. Our brothers and sisters of the public sector are facing legislation that not only will crush their health insurance benefits and pensions, but will lower the standard for working people across the nation.

This case is yet another push from corporate interest groups with the goal of breaking our strength and slashing workers' benefits. It is only together that we have the strength in numbers to fight back against these antiunion attacks. Unions are the strength of the working class. Unions ensure families have the ability to earn a living wage and receive all of the benefits and rights that they deserve. Unions are representative of every day Americans. We must never let the greed of corporate America overcome our power, but rather stand together today, and throughout the course of this case, in support of the public sector of employees to prevent the passage of so-called "right-to-work" legislation.

The fact that we are repetitively facing these threats against workers' rights makes it even more clear that we must become more diligent about voting. Every election is just as, if not more, important than presidential elections. Who we elect to represent us matters, and by not voting, we allow officials to get into office whose interests may not align with ours. This Election Day, and every election day going forward, we must pledge to get out to the polls and vote for candidates who we can be sure will stand with us and defend our interests as working men and women.



#### Workers' Comp Changes Would Hurt Workers

For over 100 years, our workers' compensation system protected workers injured on the job by providing immediate wage replacement and medical benefits without the need for a costly lawsuit. Now the obscure state agency that runs the workers' compensation system in New York is proposing to cut benefits and eliminate essential legal protections for workers – changes that would devastate workers while lining employers' pockets.

Recently, the Board released with little notice a set of proposals that would upend the system, stripping injured workers of their legal rights and drastically cutting the compensation they receive.

The first change would turn the routine medical examination, which must be done by an insurance-company paid doctor, into an adversarial interrogation. Up until now, an insurance company doctor was faced with two questions - was the worker injured on the job and if so what injuries did the worker sustain? Under the proposed regulations, workers - who may or may not speak or read English— would be required to answer a questionnaire that could force them to make statements that could hurt them in future legal proceedings. Yet, they would have no right to have a lawyer present.

What's worse, a doctor could classify a worker who refuses to answer a question or fails to answer a question to the doctor's liking as "uncooperative." Based on this classification, the Workers' Compensation Board could suspend a worker's benefits. The right to remain silent could be used against you if you are an injured worker.

The Board was charged by the state legislature to suggest reforms to the guidelines that determine the level of benefits a worker might receive depending on the extent of permanent impairment resulting from the workplace injury. These reforms were supposed to be limited to "advances in medicine" that might alter the impact of a permanent impairment resulting from a workplace injury. Instead, the Board completely rewrote key provisions of the guidelines, going well beyond the scope of their mandate and drastically cutting injured workers' benefits.

The Workers' Compensation Alliance examined potential outcomes based on Workers' Compensation claims to determine the impact of the new proposed regulations. Disturbingly, only 18 percent of the claims would be approved under the new proposed guidelines. Under the current guidelines, 71 percent of these claims would be covered.

If the proposed changes are allowed to pass, there could be a three-fold increase in uncompensated workplace injuries. Under these changes, many injured workers won't be able to pay their rent or feed their families, let alone pay their medical bills, and that is an outrage.

The Workers' Compensation Board and Governor Cuomo should scrap these regulations and start again with a public. transparent process based on facts rather than a clear agenda to cut benefits to some of the most vulnerable New Yorkers: injured workers.

# The Value of Union Membership

As your union, it is our responsibility to negotiate a contract with your employer and ensure your rights and benefits on the job are being provided and protected. When we negotiate, we focus on the benefits that matter most to you and will improve your quality of life.

Union contracts often contain pay raises, paid time off, holiday pay, and healthcare benefits. However, there are other valuable parts of being a union member that are worth just as much recognition. Another benefit in many Local 338 contracts includes the right to a paid 10 to 15-minute break that you may be entitled to take during your shift. Additionally, all Local 338 members have access to additional benefits for your benefit outside of the workplace. These include: discounts for entertainment, travel, mobile cellphone plans, etc., more than \$10,000 in scholarship opportunities, and even FREE online college

courses so you can get a degree debt-free.

I'd again like to urge you to speak with your Union or Funds/Service Representatives when you see them in your workplace. Local 338's goal of making "quality visits" to your workplace can only be as qualitative as you make them so please ask us questions, find out if you are entitled to a paid break, and inquire about the FREE college benefit as well as the other various benefits you may be entitled to.

If you are unsure who your Union Representative is, simply log-in to your Member Portal account at MyLocal338.org and visit your homepage. Just underneath your Union Representative's name, you can also find a downloadable copy of your union contract to learn more about your rights and benefits.



Since January 2017, Local 338, through grievances and arbitrations, collected funds and returned back wages to our members in excess of \$89,350.66!

#### Have Children in Childcare? Let Your Fellow Local 338 Members Tell You How Being a Union Member Has Saved Them Thousands of Dollars a Year!



#### Tahmina Tariq

Tahmina who works at Duane Reade on 42nd Street in Manhattan has a five-year-old son enrolled in child care. She was paying \$180 per week for a babysitter, but now her weekly payments are only \$44 for a day care program. That's four times less than her original payments! Since enrolling her son in the child care program, she has been able to save

that money for fun activities that before she couldn't fit in her budget.

Tahmina said that the application process was very easy, fast, and only asked for basic documents. She feels that anyone could do it, and everyone should! She also mentioned, "This program is also more educational for him. It's helping me and helping him at the same time."



Virginia Ortiz has been a member of Local 338 for two years, working at Duane Reade on Broad Street in Manhattan. Last year, she saw our email about this program and it made a life changing difference for her and her family.



Virginia has two children, a 2-year-old and a 7-year-old, and was paying \$1,100 per month for child care. After applying, her monthly payment was reduced to only \$60 per month! Since her payments have been reduced, she finally feels financially independent, secure, and confident again!



#### Akeem Johnson

Akeem who has been a Local 338 member for 15 years, and his girlfriend (who is also a member of Local 338) applied for this program to reduce the costs of childcare for their 8-year-old son and 2-year-old daughter. Their payments went from \$350 per week to no cost! "A lot of people think they want a lot of information, but they don't. They just ask for

simple papers only about two to three pages of things. I always recommend it to everyone!"

The NYC Facilitated Child Care Enrollment Project offers Local 338 Members living or working in NYC subsidies to help reduce the costs of child care. #### WE'RE HERE TO HELP!

Many kids and teenagers face the reality of bullying every single day, and more often than not, those who are a victimized by bullying do not ask for help. Even when the verbal, social, and/ or physical bullying becomes unbearable, fear of backlash from the bully, humiliation, fear of rejection and feelings of weakness or helplessness stop victims from speaking up.

Not only may victims be facing hateful behavior throughout the school day, but now they could essentially be victimized 24/7 through social media. As people that our loved ones depend on, we must make sure that we have the knowledge of how to prevent, detect and respond to bullying.

Primarily, communication is at the forefront of preventing and detecting bullying. Our loved ones should feel comfortable asking for advice at any moment, but we should also be proactive by spending some time each day asking questions about their daily life. We should also encourage kids to find an activity, interest, or hobby they enjoy. Sometimes it may be difficult to find a passion, but once it is found, it will become an opportunity to have fun and meet others with similar interests.

Hurtful words and actions can be detrimental to a victim's self-esteem and lead to more harmful effects including depression and/or substance abuse. If concerns arise, the best steps to take include:

- Listening and focusing to learn what is going on
- Assuring them that bullying is not their fault
- Giving advice through role-playing ways to make bullying stop
- Be persistent by following up with your loved one
- Consider a referral to a counselor or social worker

#### DREAMers Deben Tener la Oportunidad de Buscar el Sueño Americano

La Acción Diferida para los Llegadas en la Infancia (DACA, por su sigla en inglés) ha protegido centenares de millones de adultos jóvenes que fueron llevados a los Estados Unidos por sus padres como niños. Debido a su edad cuando inmigraron, no pueden y no deben ser responsabilizados por violar cualquier ley. Cuando se aprobó DACA en 2012, se les dio la oportunidad de obtener permisos de conducir, asistir a la escuela, obtener buenos trabajos y comprar sus primeras casas. A través de este programa, estos hombres y mujeres jóvenes han ganado la confianza para buscar el 'American Dream' un sueño que todos nuestros antepasados tenían

cuando llegaron a los Estados Unidos también.

Los 'DREAMers' han trabajado incansablemente para mejorar sus vidas y la vida de sus familias, y no hay ninguna razón justificable por la que deberían ser castigados por una decisión que fue tomado cuando eran bebés o niños pequeños. Si DACA está quitado de estos receptores, vivirán en constante temor de ser deportados a un país que no es suyo. América es el único país que han conocido. Además es probable que no tengan ningún recuerdo de su lugar de nacimiento, y para muchos, el inglés es su primer y único idioma. La amenaza de eliminar a 800.000 personas de la fuerza de trabajo y del país que han llamado su hogar desde que eran niños es una amenaza a la integridad de nuestro país y todo lo que representa. Los DREAMers han sido criados aquí en los Estados Unidos y han crecidos a ser miembros exitosos y productivos de sus comunidades. Ellos no tienen antecedentes penales, asisten a la universidad, y han luchado valientemente en nuestro ejército. Los DREAMers han sido criados como estadounidenses orgullosos como tú y yo.

La finalización del DACA también tendría un impacto devastador en nuestras economías nacionales y locales. DREAMers de hecho son contribuyentes, muchos de los cuales tienen sus propias viviendas con hipotecas, y algunos de los cuales incluso trabajan para compañías prestigiosas del Fortune 500. Perderemos billones de dólares sin sus contribuciones a nuestra economía. Los empleadores también perderán un valor muy importante; sus empleados trabajadores y calificados.

Estas son sólo algunas de las razones por las que no sólo debemos simplemente luchar contra el plan de la Administración de eliminar DACA, sino más bien luchar por una legislación que proteja a los DREAMers que ponga a estos trabajadores y trabajadoras en un camino hacia la ciudadanía a través del DREAM Act. Esta legislación otorgará un estatus legal permanente a estos adultos jóvenes que fueron llevados aquí como inmigrantes indocumentados siempre que satisfacen los requisitos. Estos hombres y mujeres jóvenes no merecen vivir en el temor de una decisión que podría desgarrar sus vidas y sus familias en cualquier momento. Debemos mostrar nuestra unidad en apoyo al DREAM Act para preservar el 'American Dream' para todos, para ser esa luz brillante en la colina, para seguir siendo la tierra no sólo de los libres y los valientes sino de la compasión y la esperanza.



# La Convención Constitucional Perjudicará a las Familias Trabajadoras **VOTE NO** el 7 de noviembre

Además de votar en elecciones locales importantes, también votarás sobre la "Propuesta # 1" que estará en el reverso de tu boleta electoral. Aquí hay algunas cosas que debes saber sobre la Convención Constitucional antes de que vayas a tu sitio de votación.

#### Pone TUS Derechos En Riesgo

Una Convención Constitucional dará a los grupos de interés especiales la oportunidad de hacer cambios a los derechos y protecciones, como compensación de trabajadores, que los hombres y mujeres trabajadoras han tenido durante décadas. Estos grupos ricos con intereses especiales pondrán su agenda delante de la tuya, realizando cambios que se beneficien a sí mismos y dejando a las familias de Nueva York para hacer frente al impacto en nuestra seguridad, el medio ambiente y nuestras escuelas.

#### Es Una Malgasta De Nuestros Dólares Fiscales

No hay un calendario proyectado para cuánto tiempo podría durar la Convención Constitucional. Además, si los funcionarios electos sirven en la Convención, podrían obtener hasta 80.000 dólares por encima de los sueldos (pagados por los contribuyentes) que ya reciben. Una convención podría costar a los contribuyentes cientos de millones de dólares, que, en cambio, podrían ser utilizados para otros programas y servicios importantes.

#### Los Trabajadores Podrían Perder El Derecho A Luchar Por Salarios Y Beneficios Mejores

Nueva York es uno de los únicos estados que explícitamente incluye el derecho a negociar colectivamente un contrato sindical en su Constitución Estatal. Si hay una Convención Constitucional, el lenguaje protector podría ser eliminado, y esto haría la habilidad de tu unión a negociar un buen contrato en tu nombre mucho más difícil.

En el Día de las Elecciones, recuerda volver tu boleta electoral y votar en contra de la Convención Constitucional votando NO en la Propuesta # 1.

Desde que inscribió a su hijo en el programa de cuidado infantil, ella ha

sido capaz de ahorrar ese dinero para actividades divertidas que antes ella no podía encajar en su presupuesto.

Tahmina dijo que el proceso de solicitud fue muy fácil, rápido, y pide documentos básicos. Ella siente que cualquiera persona podría completarlo, y todo el mundo debería. También mencionó: "Esto también es más educativo para él. Me está ayudando a mí y ayudándolo a él al mismo tiempo.

## Virginia Ortiz

Virginia Ortiz ha sido miembro del Local 338 durante dos años, trabajando en Duane Reade en Broad Street en Manhattan. El año pasado, vio nuestro correo electrónico sobre este programa que hizo una gran diferencia de cambio de vida para ella y su familia.



Virginia tiene dos hijos, un niño de 2 años y un niño de 7 años, y estaba pagando \$1,100 por mes para cuidado de niños. ¡Después de aplicar, su pago mensual se redujo a sólo \$60 por mes! Desde que sus pagos se han reducido, finalmente se siente independiente económicamente, seguro y confianza de nuevo.

#### Akeem Johnson

Akeem, quien ha sido miembro del Local 338 durante 15 años, y su novia, que también es miembro del Local 338, solicitaron este programa para reducir los costos de cuidado de su hijo de 8 años y su hija de 2 años. ¡Sus pagos redujeron de \$350 por semana a ningún costo!
