Supporting the Revival of the Poor People's Campaign

From New York to California, Local 338 joined thousands of union members, including from the RWDSU and UFCW, that have turned out in full force over the past few weeks to support the revival of the Poor People's Campaign.

"The Poor People's Campaign: A National Call for Moral Revival," was founded by Rev. Dr. William Barber II and Rev. Liz Theoharis, the Kairos Center for Religions, Rights and

Social Justice at Union Theological Seminary, and hundreds of local and national grassroots groups. This campaign builds on the legacy of Dr. Martin Luther King Jr. and others, who organized actions in 1968 to demand economic and human rights for poor Americans of all backgrounds.

The revival campaign began on May 14, and there have been a series of events at state capitols across the country as part of the campaign's "40 Days of Moral Action" for the purpose of challenging systemic racism, poverty, the war economy, ecological devastation, and the nation's distorted morality. The campaign's "Global Day of Solidarity" rally in Washington, D.C., on Saturday June 23rd, marked the finale of the "40 Days of Moral Action," which members and staff of Local 338 had the opportunity to attend.

"The Poor People's Campaign believes, as our union family does, that our economy can and should work better for everyone," said UFCW International President Marc Perrone during the rally in Washington, D.C. "Wage inequality, the assault on voting rights, underemployment, and the attacks on immigrant and refugee communities are all part of a systemic effort to disenfranchise poor communities. We're proud to support the Poor People's Campaign because, if successful, it will bring hard-working families more power to build better lives."

ROSA URQUIZA'S AMERICAN DREAM

Rosa Urquiza has been a member of Local 338 for 23 years, and we are so proud to announce this news and congratulate her on officially becoming a United States citizen!



Rosa moved to New York when she was 19 years old, escaping the civil war in her birth country, El Salvador, a life that could not lead to a promising future. At the age of only eleven years old, she had to leave school to begin working and never had that opportunity to live her childhood. When she made the move from El Salvador to the United States, it was a big change, but as soon as she made it here, she began building her life. She was working two part-time jobs for over three years at ShopRite and Nathan's, until she was offered a full-time position in ShopRite's produce department, where she has been working ever since!

Six years ago, Rosa received a letter in the mail; it was a court order for deportation. She recalls it being the worst day of her life because as a hardworking single mom of four children, she just opened a piece of mail that could separate her from her family and the life she has built forever. When Rosa appeared in court, she proved her honesty, hard work and clean record. Her eldest son was also asked to testify on her behalf, helping the Judge understand how torn apart he would be without his mother and how much his siblings needed her.

After waiting a few weeks to hear back the results from court hearing, she was notified that her stay would be extended, and after a few years, she was finally able to apply for citizenship and received it!

Rosa said, "When you want something, you do it. Especially when it's something like becoming a citizen of the United States!" She is so proud to be an American and she is grateful for being given the opportunity to give her family a better life. Her children are on paths to bright and successful futures. Currently, her son Marvin is graduating with an engineering degree, Michael is attending John Jay College with aspirations to become an immigration lawyer, Jaime is graduating high school this year, and her 10 year old Alexandra is thriving in elementary school.

The day that she went for her citizenship exam, her daughter said to her, "Mommy, if you pass, you'll be waiting for me at the bus stop. That's how I'll know." Well, that day, mommy made it to the bus stop! Alexandra was filled with tears of joy that day as the bus rolled up to the stop and she hopped off to run into her mom's arms. This moment for Rosa was when she could say, "I was breathing... but only halfway. Now, I can breathe!"

We are so happy for you and your family, Rosa!








Where Are They Now?

The Supreme Court just recently ruled against working people in their decision in the Janus vs. AFSCME case. While this devastating 5-4 ruling will impact the future of the labor movement in a way it has never been hit before, we will not let "right-to-work" for less laws break us. Honoring the Fallen on Workers' Memorial Day

To commemorate the day, Local 338 staff attended several events, including the annual Long Island Workers' Memorial Committee event. Our own Union Representative, Fred Wren, opened the service as the newly elected chair of the committee. Local 338's Service/ Funds Representative Maria DeGirolamo also serves alongside Fred on this committee. Speakers also included our President, John Durso, and family members of victims. This year's ceremony was particularly important to us as we honored the memory of our member, Irene Espinal, an employee at IAHD who passed away while on the job in August of last year.

Another important event for union members and all workers

to recognize is May Day, a holiday that brings attention to workers' rights and the accomplishments made by the labor movement. Local 338 staff attended a service at St. Patrick's Church in Bay Shore and a rally in Washington Square Park to celebrate the day. Perhaps the most tragic event in labor history is that of the Triangle Shirtwaist Factory fire, which kick started the labor movement to rise up and help workers get the rights and protections they have today. Even with many successes, there is always room for expanding protections for workers. That is why we continue to "mourn the dead, fight like hell for the living," a phrase widely used and put into practice each and every day during this period of the year.

RWDSU Members Speak Out Against Sub-Minimum Wages

In June, RWDSU members testified at New York State Department of Labor hearings in the Bronx, as workers and activists gathered at rallies to call for an end to the so-called "tip credit." At these hearings and others like them throughout the state, these activists spoke out to change a system that hurts countless workers in a number of industries, including hundreds of RWDSU members who work at car washes throughout New York City.

The RWDSU and other unions and worker-advocates are leading the charge to get rid of the so-called "tip credit," which has

allowed operators to pay workers well below the minimum wage on the theory that tips will more than make up the difference. In reality, however, this system has created a confusing web of different minimum wages

different minimum wages that often provides employers with an outrageous license to steal. In many cases, including car wash, a mind-boggling morass of differing sub-minimum wages – which can change weekly – leaves workers scratching their head over what their actual minimum wage is supposed to be.


Workers have testified about the inability to live in dignity because they can't afford decent housing for their families, and how they can't look for other work because they cannot adequate transportation. Workers struggle with paying their bills and putting food on the table. For the car wash workers in New York City - especially those without union representation - sub-minimum wages are a vehicle for wage theft and systemic underpayment. Investigations have shown that employers don't always make up the extra pay for workers when tips are short, and car wash workers don't always receive the tips

customers presume are going into their pockets. We shouldn't be giving unscrupulous employers additional opportunities to underpay their workers, and that's exactly what tip credit does in the car wash industry and many others. Car wash operators have been fined and directed to make restitution for wage theft to the tune of millions of dollars.

In many industries, immigrant workers are particularly susceptible to tip credit-aided wage theft. Nail salon workers, deliverymen, car wash workers, restaurant workers; all are affected by wage theft and the sub-minimum wage loophole that makes it easier for employers to underpay them and even steal from them.

The hearings – ordered by New York Governor Cuomo - were an important next step in ensuring that 5,000 car wash workers in New York will soon have a chance to earn fair wages for

their work, and that no worker in the Empire State is underpaid and impoverished. It's time to get rid of the tip credit, eliminate legal subminimum wages, and raise wages to make sure that all workers have a chance to thrive in New York.



Anger Management

Anger is something that everyone experiences. It can be caused by something as simple as sitting in traffic to something more extreme, like missing your flight at the airport. Both of these things can cause different levels of frustration, but people who struggle with anger management tend to handle them differently.

Anger management is not suppressing or ignoring what makes you angry—doing that only makes how you're feeling worse, and makes it more likely that you'll lash out in the future. Holding onto anger without expressing it in a healthy way is not only harmful to your relationships, but to your physical health as well.

Here are a few tips to help you better manage your frustration. The first, and possibly the most important, is to think before you speak. Sometimes taking a moment to really consider what you're about to say can make a huge difference between maintaining or ruining a relationship. Another tip is to stick with "I" statements. This is an effective way to be aware and respectful of the feelings of others when explaining why you're upset. Try not to shift the blame to the other person. An example of an "I" statement would be, "I'm upset because you left the table without offering to help with the cleanup" instead of "you never help out around the house."

Change can be difficult, but breaking habits that keep you stuck in reoccurring, damaging situations may be easier to do with the help of a professional. If you feel managing your emotions or outbursts of anger is getting in the way of work, relationships or simply your own personal health, you can call the Member Assistance Program for help in choosing a professional that best fits your needs.




























We March with Pride!
