Health Care Reform Will Help Working Families



n March 23, 2010, President Barack Obama signed historic health care reform legislation that while not perfect will lead to significant improvements in health coverage for generations to come. By fighting for and winning passage of the bill, President Obama took a huge political risk. But his leadership on this issue will help provide millions of Americans with better access to more affordable health care.

The debate surrounding the health care bill was at its best moments informative and Stuart Appelbaum, highlighted some of the very real problems that **President, RWDSU** our broken health care system has created. At its worst, the debate was confusing and needlessly

divisive. Opponents of the bill often resorted to gross exaggeration to derail efforts to pass it. Some used the health care debate as a proxy in an effort to undermine President Obama.

> But the truth behind the bill is really far more mundane than either side admits. The bill, called the Health Care Reconciliation Act of 2010, achieved many elusive goals that reformers had sought for decades. While the new law will not provide coverage for every American, it will extend coverage to 32 million of the

uninsured. It will also help slow the rapid rise in health care costs, and even more importantly will put the brakes on some of the worst abuses of health insurance companies. No longer will insurance companies be able to make unreasonably high increases in medical premiums, place caps on health care benefits, or deny coverage to those with pre-existing or chronic conditions. These are important reforms that will benefit all

The bill is not a government takeover of the health care system. And it will not raise the deficit. The reason? While the bill does not ask employers to do nearly enough to meet their responsibility to provide adequate health care for employees, it is mostly financed fairly. Expanded coverage is provided through cost savings on certain aspects of Medicare and a progressive tax on the wealthy.

Overall, these improvements will bring us closer to long-term health security for working families.

The RWDSU praises President Obama and the U.S. Congress for making the right decision to support real health care reform. And of course, this battle couldn't have been won without the support of union members across the country. Working people rallied and made phone calls to members of Congress, wrote letters and attended town hall meetings. We countered the lies and distortions of the right-wing and helped get the truth out. By standing together we made a real difference for millions of working families.

Cell Phones for Safe Horizon



What Healthcare Reform Means for Retirees

he passage of the healthcare reform legislation means good news for retirees. The legislation includes some major provisions which will benefit seniors directly. Such benefits include:

- In 2010 there will be a \$250 rebate to Medicare Part D beneficiaries who had to pay for their medications because they reached the gap in coverage known as the "doughnut hole". Beginning in 2011 there will be a 50% discount on all brand- name drugs you purchased while in the "doughnut hole." Also, additional discounts on brand-name and generic drugs will begin to be phased in until the doughnut hole is completely eliminated by 2020. In other words, many Medicare recipients will start saving money on their prescriptions this very year.
- Effective January 1, 2011, preventative services (such as well care check-ups and certain cancer screenings) will have no co-pays or co-insurance, and deductibles will not apply to them.
 - The last major benefit for retirees is the conversion

of Medicare Advantage plans to reformed payments. The law contains provisions which begin to reduce overpayments to private insurance companies for the administration of Medicare Advantage plans so that they are paid similarly to the cost of care under traditional fee-for-service Medicare. On average, Medicare Advantage plans are paid 14% more than the actual cost of services rendered to enrollees. These overpayments drain Medicare, raise premiums for all Medicare enrollees, and cost taxpayers \$12 billion each year.

It is important to understand that the reforms do not cut benefits for Medicare recipients, contrary to what certain alarmists and political opponents of President Obama are incorrectly stating. The reform bill is an important first step in expanding coverage for those with no coverage and in otherwise addressing the very complex issues of health care in this country. We will be sure to bring to your attention any new information that we receive regarding health care reform that may be of interest to you.

he passage of the Health Care Reconciliation
Act of 2010 is a truly historic event for our
country, the likes of which have not been seen
since the creation of The Social Security Act of
1965. This progressive legislation is an important
step in ensuring Americans' ability to access health care.
Now, 32 million uninsured Americans will finally have the
opportunity to receive affordable AND quality health care
coverage.

Since last summer Local 338 has been actively engaged in the struggle for health care reform. Beginning with Suffolk County Congressman Timothy Bishop's Town Hall meetings, our efforts were met with great opposition. However, over the past year we have stood strong and continued to show our support by attending rallies hosted by elected officials and other unions across New York City and Long Island. President John Durso even spent time lobbying in Washington, D.C. speaking with members of the United States Senate and House of Representatives to stress the importance of health care reform. Our members have also been wonderful in their commitment to the cause, contacting their members of

Congress to urge them to support reform legislation, as well as attending numerous rallies.

Health care reform is necessary for all working men and women. The ever rising costs of health care are crushing to families, businesses, and local government budgets. In 2007 the United States spent approximately \$2.2 trillion on health care which is about \$7,421 per person. Americans spend more on health care then on housing or food causing some families to make that impossible choice between paying their rent or their health insurance. Unfortunately, our wages have not kept up with the increasing costs of health care.

Thus, it is crucial we remember that this bill does not simply aid those who do not have health insurance. Individuals with private health insurance will reap the benefits of the bill's numerous consumer protection clauses.

With the Health Care Reconciliation Act, no longer will hard working men and women be forced to choose between providing food or health care for their families. Insurance companies will finally be held accountable for their practices that place greed and profit before the well-being of middle-class Americans. Those with pre-existing conditions will not have to fear being denied coverage nor will those who become sick have to worry about having their coverage dropped because they are considered too risky. It is despicable that women diagnosed with breast cancer should be more concerned with whether or not their insurance will cover the cost of treatment rather than focusing on getting healthy. Additionally, young adults will now be covered under their parent's insurance until they're 26 providing support while they are in college and prepare to enter

the workforce. Health care reform will also help the our economy by reducing the deficit by trillions of dollars over the next two decades.

Health care reform has been a long and grueling fight and there may have even been moments where our members of Congress considered succumbing to the bill's intense and often overwhelming opposition. However, these men and women stood strong and ultimately made the courageous choice to positively change the lives of millions of the

country's working men, women, and children. These leaders kept their promises of support and it is essential we remember to do the same for them in November.







Long Needed Healthcare Reform is a Victory for the Middle Class and the Nation

he passage of the Health Care Reconciliation Act of 2010 is a historic and monumental victory for the nation. President Obama's signature not only enacts the much needed reform into law but repaaresents a shift in Washington; a change in philosophy from the pro-corporate agenda of the provious decade.



have brought our nation to it's economic knees.

Such dramatic change and a shift in a long time ideology does not come easy. In the year leading up to the passage of healthcare reform the insurance industry spent over a hundred million dollars to "kill the bill." Again, lies and deceit consumed the nation as the scare tactics worsened with fallacious talk of death panels. draconian cuts to Medicare and the big bad government taking control of your medical decisions and care. Through all the obstructionist tactics, blatant lies and non-stop attacks the leadership in Washington stood strong. Their resilience and hard work has paid off and as a result 32 million Americans will finally have the opportunity to access the health care coverage they have been denied. Approximately half of them will be receiving coverage through a new "insurance exchange" that provides coverage options under plans that must meet rules on benefits and premiums.

Under the new reforms, millions of Americans with pre-existing conditions will no longer have to worry about being denied coverage including many women who were previously denied coverage because of a battle with Breast Cancer. Those who become sick no longer have to fear having their coverage dropped because their care is considered too expensive, as it is now illegal for insurance companies to do so. Seniors will see decreases in their costly deductibles for prescriptions that fall into Medicare's "Donut Hole," with a \$250 rebate this year and beginning next year a 50% discount on brand-name drugs in the



donut hole until it is closed completely in 2020. Young adults will now be covered under their parent's insurance until the age of 26 providing them a level of security while in college and preparing to enter the workforce. Furthermore, insurance companies are now prohibited from placing lifetime caps on health benefits that limit the amount of care an individual can receive.

These are just some of the immediate fixes to the healthcare system we will realize in the near future.

The Health Care Reconciliation Reform Act will also aid in the economic recovery of the nation. The reforms help small businesses and uninsured individuals get affordable coverage with subsidies for low and moderate-income workers. It is projected to reduce the federal budget deficit by \$1.3 trillion over the next two decades and increase Medicare solvency by almost a decade. By bringing down the cost of insurance and giving individuals access to affordable healthcare, workers will no longer feel compelled to remain at their jobs out of fear of losing their health benefits. Instead, through the portability of health care coverage exchanges, working Americans will have more incentive to seek out and advance to better paying employment. Such portability and affordability of health insurance will lead to entrepreneurship and a rise in small businesses, providing a necessary boost for the economy.

For the first time in our nation's history Insurance companies will be held accountable. For the first time in a very long time, Washington is standing up to corporate America and making the well being of the middle-class it's the top priority. Not since the passage of The Social Security Act of 1965, which created Medicare and Medicaid, has the United States seen a truly progressive step in ensuring Americans' ability to access health care. It is important that we remember that over forty years ago these programs were also met with fervent opposition. Yet, today we take the benefits of Medicare and Medicaid for granted as commonplace and once the Health Care Reconciliation Reform Act is implemented, we will view these crucial reforms in that same light. Someday in the near future, our children's generation will wonder why anyone would have tried to stand in the way of such common sense

s Field Director of Manhattan and New Jersey for Local 338, it is my job to coordinate with Union and Service Representatives. Local 338 represents more than 18,000 members working for such companies as Duane Reade, Food Emporium, and Gristedes, amongst others. I see first hand the impact our union has on the lives of our members.

As Union Representatives,

it is our job to enforce collective bargaining agreements with each employer, and make sure that the terms and conditions are followed. We are the support mechanism for our rank and file in the shops. We visit each shop every two to three weeks, handling any problems that arise and also to make sure the company knows we are there to keep them honest.

Our staff has a huge responsibility, and one my colleagues and I never take lightly. Anything that we do, any decision that we make, will affect someone's life, their family, and their future. If a member loses their job or benefits it impacts every aspect of their life.

Although the union assists in contractual and worker

rights issues, we also handle members' concerns on an individual basis. If an individual has certain problems that interfere with their ability to work even alcohol and drug problems – we do what we can to steer them in the right direction and help them out. In this way, the union is more like a family.

I am often asked, "What does it mean for me when I join a union?" To me that answer is simple. When you are part of a union you are part of a family, a family that protects its own. It is the union that secures your medical, prescription & pension benefits. It is the union that holds the company's feet to the fire enforcing the contract. It is the union that fights to secure your vacation, sick and personal time. And it is the union that makes sure you are treated with the dignity and respect you deserve at your job!

In the coming years, Local 338 will continue to reach out to new members. The main focus remains on growing the union. There is strength in numbers and the larger our union becomes the more bargaining power we have. 1) Carnage East House:

The Contract covers healthcare workers who work in an enriched housing facility. The Workers ratified a new 3 year agreement that provides wage increases, continuation of medical benefits, and pension provisions.

2) Lane Bryant Inc.:

The Contract covers retail workers who work at various store sites in New York and Connecticut. The Workers ratified a new 3 year agreement that provides wage increases, continuation of medical benefits, and lowered the number of hours for that a part-time employee has to work to get vacation.

3) King Kullen (Pharmacists):

The King Kullen Pharmacists agreed to a similiar agreement as the Waldbaum's Pharmacists with

all the same negotiated benefits including retro wage increases back to September of 2008.

Local 338 Members Lobby in Albany to Save Jobs!

his year has proven to be another tough year economically for New York State. The economic crisis has been a serious concern for some of our employers in the healthcare sector, many of whom receive funding as part of the NYS budget. Recently, Local 338's Political Action Team was joined by several of our members who work for the Institute for Applied Human Dynamics (IAHD) for a trip to Albany to lobby the State Senate and Assembly. Discussions revolved around maintaining the funding levels for agencies overseen by the Office of Mental Retardation and Developmental Disabilities (OMRDD) proposed in the preliminary budget. Any cuts to the OMRDD budget will have a direct impact on the members working in these facilities. The team met with members and staff from the New York State Assembly & Senate to discuss the good work done by the nearly 600 members working with people with developmental disabilities at IAHD. They relayed the message that any cuts in funding will have a direct impact on the consumers they service with reductions in care and or cuts in various programs.

Metropolitan Transit Authority Cuts Back!

ue to a \$400 million budget gap the M.T.A. (Metropolitan Transit Authority) has created a plan that drastically changes or eliminates the service it provides. The proposal, approved on Wednesday, March 24, will affect millions of New Yorkers, including Local 338 members.

Under the new plan the V and W subways will be eliminated, while the M will be rerouted, no longer running in parts of Brooklyn and lower Manhattan. Thirty-four bus routes throughout the five boroughs will be cut altogether. Service on the Metro-North and Long Island Railroads will also be revised, offering fewer trains at certain times of day. Additionally, the M.T.A. is considering getting rid of discounted Metrocards that are offered to students.



These changes will go into effect between the months of May and June. However, they will only save the M.T.A. part of their overall budget gap. As a result, we may see more cuts in service, as well as a fare hike, which will only further hurt working families in our area. The M.T.A. has created a complete list of the numerous changes in bus, subway, and railroad service which, is available on their website.

La Reforma de Salud Que Se Necesitaba Una Victoria para la Clase Media y la Nación

a aprobación de la Ley de Reforma de Salud del 2010 es una victoria histórica y monumental para la nación. La firma del Presidente Obama no solo ratifica la tan necesitada ley de reforma, si no que representa un cambio en Washington; un cambio

filosófico de la agenda
pro-corporativa de la década pasada, a una donde la clase
media de América es ¡la prioridad! Esta es la verdadera
razón que se esconde detrás de los que se oponen a la
reforma de salud y la razón por la cual hay tanto veneno
por parte de los derechistas y conservadores. Este fué un
largo y agotador esfuerzo, primeramente por la oposición
Republicana, la cual recurrió a escandalosas y vergonzosas
mentiras promocionando miedo en un intento desesperado
por mantener las pólizas de desregulación que han llevado a

nuestra nación a una economía devastadora.

Un cambio tan dramático como este no llega fácil, especialmente donde han existido otros tipos de ideologías por tanto tiempo. En el año previo a la culminación y aprobación de la ley de Reforma de Salud, las compañías de seguro gastaron más de cien millones de dólares para "aniquilar el proyecto de ley."

Una vez más, la nación era consumida por mentiras y engaños, al mismo tiempo, empeoraban las tácticas para atemorizar a los consumidores con mitos tales como los paneles de muerte, severos cortes al programa de Medicare y el gran y malvado gobierno estaría tomando control de nuestras decisiones en cuanto a salud y el cuidado a la que la misma se refiere.

A pesar de los constantes ataques y mentiras obstruccionistas, el liderazgo de Washington permaneció fuerte. Su resiliencia y arduo trabajo valió la pena y como resultado de esto, 32 millones de Americanos podrán, finalmente, tener la oportunidad de tener acceso a un cuidado de salud que se les había sido negado. Aproximadamente la mitad de ellos estarán recibiendo cobertura a través de un "intercambio de seguro" que provee opciones bajo planes que estarán sujetos a cumplir con las reglas y las primas de los beneficios.

Bajo la nueva reforma, millones de Americanos sufriendo condiciones preexistentes no tendrán que preocuparse por ser rechazados, incluyendo muchas mujeres que fueron diagnosticadas con Cáncer de Seno pero se les fue negado un seguro y la atención medica.

Aquellas personas que desarrollen enfermedades las cuales se consideren costosas para las compañías de seguro, podrán ser atendidas sin ningún problema, y mejor aun, sin ser rechazadas por las compañías de seguro ya que seria un proceder ilegal.

Las personas mayores de edad verán descuentos en los altos deducibles de las medicinas que caen en el "Donut Hole" con un descuento de \$250 y comenzando el próximo año con un descuento



del 50% en medicinas de marcas conocidas hasta que el circulo sea cerrado por completo en el año 2020. Aquellos jóvenes que estén asistiendo a la Universidad, podrán continuar su cobertura bajo el seguro de sus padres hasta que cumplan 26 años de edad dándoles así, un mejor nivel de seguridad y estabilidad

mientras se preparan para entrar a la fuerza laboral.

Por otra parte, ya esta prohibido que las compañías de seguro pongan limites a beneficios de por vida que limitan la cantidad de cuidado que un individuo pueda recibir.

Estos son solamente algunos cambios inmediatos que veremos ser implementados al sistema de salud a un corto plazo.

La aprobación de la Ley de Reforma de Salud del 2010 también ayudara a la recuperación económica de la nación. Estas reformas ayudan a los pequeños negocios y personas sin seguro a obtener cobertura asequible con subsidios que ayudaran a trabajadores con bajos y moderados ingresos.

Está proyectado a reducir el déficit federal por \$1.3 trillones en las próximas dos décadas y aumentar la solvencia en el programa de Medicare en aproximadamente 10 años. Los trabajadores no se sentirán forzados a permanecer en sus trabajos debido al miedo que puede causar perder sus beneficios de salud, ya que el costo del mismo bajara dándoles a los individuos acceso a un seguro de salud más favorable.

En cambio, a través de la portabilidad de intercambios de seguro de salud, los trabajadores Americanos tendrán más incentivos para conseguir y avanzar hacia buenos trabajos que serán mejor remunerados. Esta portabilidad y accesibilidad a un seguro medico llevara al incremento empresarial y de pequeños negocios proveyendo así el impulso necesario para mejorar la economía.


Por primera vez en la historia de nuestra nación, las compañías de seguro tendrán que rendir cuentas. Por primera vez en mucho tiempo, Washington se esta enfrentando a la América Corporativa y esta poniendo como prioridad el bien estar de la clase media.

No era desde la aprobación del Seguro Social en 1965, lo cual creo a Medicare y Medicaid, que los Estados Unidos veía un verdadero paso progresivo a asegurar la habilidad de los Americanos a alcanzar y acceder seguro y cuidado medico.
