This July, Local 338 attended the quadrennial Retail, Wholesale, Department Store Union (RWDSU) Convention! This convention is held every four years to elect our national union's leadership and set goals for our union.

This year, we proudly re-elected the leadership team, President Stuart Appelbaum, Secretary-Treasurer Robert Layng, Jr., and Recorder Joseph Dorismond for another term. They have been strong leaders and advocates for the workers they represent throughout the pandemic and have helped to ensure that workers across the country were being treated with dignity and respect. They helped our



union navigate the pandemic and provided important guidance on how to protect our members.

In addition to re-electing the leadership team, there was also an inspiring lineup of speakers, including organizers from the Amazon warehouse in Bessemer, Alabama, workers from Starbucks Workers United, and United States Secretary of Labor Marty Walsh, who vowed to continue to fight for the union movement on the federal level.

Amy Albrecht, a Local 338 member working at MedMen in Utica, participated in a panel on worker organizing. She was able to provide a unique point of view, because unlike the other workers on the panel, she didn't experience any union busting while her workplace was organizing. That's because of a clause included in the Compassionate Care Act, which requires employers to sign a Labor Peace Agreement when obtaining their license to operate in New York—meaning they can't interfere if workers want to organize!

"Being in a new, up and coming industry, we didn't have to go through union busting," she said. "The thing that I'm most thankful for is that together with the other unionized grow sites, we are setting the standard for the industry."

It was an inspiring week, and we are looking forward to continuing to work with the leadership at the RWDSU to better the lives of

workers across New York! Congratulations once again to President Stuart Appelbaum, Secretary-Treasurer Robert Layng, Jr., and Recorder Joseph Dorismond on their re-elections!














Pindar Vineyards Member Martir Zambrano Diaz Honored by New York State AFL-CIO

On August 16th, the New York State AFL-CIO held their biannual COPE Convention, where delegates from unions across the state, including Local 338, came together to endorse candidates for the 2022 midterm elections. Together, we endorsed



several candidates for offices on both the state and federal level, who we believe will be strong advocates for working people in government.

During his opening remarks at the beginning of the convention, New York State AFL-CIO President Mario Cilento spoke about the progress that has been made for working people in New York over the last several years. Martir Zambrano Diaz, one of Local 338's members at Pindar Vineyards, was honored for being one of the

first farmworkers in New York to unionize under the 2019 Farm Laborers Fair Labor Practices Act. This legislation gave farmworkers several basic labor rights they had been denied for decades, including the right to unionize.

Martir's courage and determination to create a better workplace for himself and his coworkers helped pave the way for other farmworkers across the state to unionize. It was not easy to do, and we admire his commitment to the cause. We are incredibly proud to represent him and all of the workers at Pindar Vineyards—congratulations on this well-deserved honor, Martir!













Being in a union is not only being part of a family, but you're also part of a team. We're a lot stronger when we work together and show up for each other--especially during contract negotiations, charitable events facilitated by Local 338, and at the ballot box. As union members, it is your right to have a seat at the table during contract negotiations. We are able to negotiate stronger contracts when we have member participation—either by reaching out to your Union Representatives directly with things you hope to secure in your next contract, or by attending our membership meetings with your questions and suggestions.

We cannot stress how important it is for our members to be politically involved. If this year has taught us anything, it's that the rights of working people are not guaranteed. The Supreme Court has overturned several landmark cases this year, and some justices have signaled that they may continue overturning the rights Americans have fought for when they reconvene this fall. This puts

the rights of working people at risk, making it more important than ever to have pro-worker candidates in office on the local, state, and federal level. We encourage you to get out and vote, and if you aren't already, contributing to the Local 338 Political Action Fund. The Local 338 PAC helps us support candidates who are going to protect the rights of working people. You can sign up here.

Finally, one of the things we're proudest of is our union's commitment to giving back to local communities both during and after the holiday season. Every year we partner with local organizations to donate toys, food, coats and more, and without fail, the membership of Local 338 shows up to help every time. Because of you, we have been able to make a difference in the lives of those in need across the state. As we approach the holiday season, we will once again be accepting toy, food, and coat donations for our annual charitable drives. Margaret has been working on the farmworker organizing campaign since they first came on staff in January and has played an important part in the recent unionization of the Paumanok and Palmer Vineyards.

Their role in farmworker organizing requires them to serve as a guide for farmworkers—because many of them don't know their new labor rights under the Farm Laborers Fair Labor Practices Act, Margaret works to inform them of what they're now entitled to under the law, including the right to organize. Margaret says the best part of being an organizer is helping workers understand that unionization is possible, and they have the power to improve their workplaces by coming together.

"There's nothing like that feeling you get when meeting with workers and you see it click in their eyes like, 'oh, I can do something!" they said.

When they're not organizing, Margaret enjoys playing the accordion, drawing, and writing—they studied creative writing in undergrad and says they use the same storytelling skills when organizing workers. Margaret's been hard at work since joining our team in the beginning of the year and we look forward to seeing what else she and the organizing team can accomplish in 2022!

Welcoming New Members to Our Union Family

Throughout the year, Local 338 organizers and representatives have been meeting with workers across New York to discuss the benefits of joining our Union. We have also welcomed workers from a variety of different industries across the state to our union family! Thanks to the RWDSU who organized this group, in July, Housing Works, a nonprofit agency that provides important social services throughout New York City, ratified their first contract, four years after their organizing campaign first started. It was a difficult journey, but we are thrilled that they have reached an agreement with their employer and can now enjoy the full protections of a union contract.

In August, the workers at Paumanok and Palmer Vineyards in Aquebogue, New York became the second group of agricultural farmworkers at a Vineyard to unionize under the New York State 2019 Farm Laborers Fair Labor Practices Act. They will join their Local 338 brothers and sisters at Pindar Vineyards in the union movement, and we are looking forward to negotiating on their behalf.

Also in August, we welcomed workers from the Child Center of New York: Youth Development Division! These members work at after school programs for students across New York City and provide important educational support. Finally, 16 building maintenance employees from the Lower East Side People's Mutual Housing Association ran a successful organizing campaign and voted to join Local 338.

It has been a very exciting year for working people, and we look forward to the strength of the union movement growing as workers continue to take advantage of their power

to improve their workplaces through unionization.

Patients are Now Protected from Surprise Medical Bills

As of January 1, 2022, the No Surprises Act is in effect. Most often, patients who have private health insurance could receive surprise billing—also called balance billing-when being treated at an innetwork hospital or ambulatory center by a doctor who does not take their insurance. This can happen when you can't control who is involved in your care—like when you have an emergency or when you schedule a visit at an in-network facility but are unexpectedly treated by an out-of-network provider. The surprise bill is often a result of your insurance not covering the out-of-network cost for the care you received from an out-of-network provider. However, this new legislation will protect you from having to pay these bills: usually, you will only have to pay what you'd typically pay for care received by someone who is in-network and takes your insurance.

For the uninsured, the No Surprises Act makes sure that patients receive an estimate of how much their care will cost before you receive it, typically 3 days before the scheduled visit. If the final bill is at least \$400 more than the estimate given before the patient received treatment, they can dispute the charge. This legislation is a huge step forward for patients across New York—it makes the billing process much more transparent and understandable. Now, health care providers and facilities must give you an easy-to-understand notice explaining the billing protections and that you will be receiving care by an out-of-network provider.
